MINUTES

A. CALL TO ORDER

Chair Rivera called the meeting to order at 6:11 p.m.

B. APPROVAL OF MINUTES

1. Board Member Osgood made a motion to approve the minutes of the Parks and Recreation Board meeting of October 23, 2012. Board Member Abell seconded the motion. The motion carried on a vote of 5-0, with Vice Chair Francell and Board Member Almanza off the dais.

C. CITIZEN COMMUNICATION

Bruce Willenzik requested better planning of the 2013 Trail of Lights event.

Bill Glass requested support of the Gracywoods Neighborhood Association request to have Austin Energy raise the power lines in the park (Gracywoods), as to prevent further damage to the oak trees.

David Orshalick requested for the Director to provide the Board with quarterly updates on the development progress of the Northwest Nature Park.

Zoila Vega requested the Board discuss the watering of the heritage trees at Parker Lane Park at their next meeting.

Michael Fossum requested the Board to support the Gracywoods Neighborhood Association's request to Austin Energy to raise the power lines.

Chong Shin, Nan Clayton and Bob Coffee all spoken in favor of item #6.

D. NEW BUSINESS: DISCUSSION AND ACTION ITEMS

2. Board Member Abell made a motion to recommend to Council the Permanent Use (13,474 sq. ft.), not to exceed 1,095 calendar days on parkland located at Shoal Creek Greenbelt at West Avenue, with a mitigation value of \$70,738.50 and improvement to parkland is \$2,700,000. Board Member Osgood seconded the motion. The motion carried on a vote of 7-0.

- 3. Board Member Abell made a motion to recommend to Council the Permanent Use (10,320 sq. ft.), not to exceed 1,095 calendar days on parkland located at Shoal Creek Greenbelt at West Avenue, with a mitigation value of \$54,180.00 and improvement to parkland is \$57,600 per year for maintenance of the greenbelt. Board Member Osgood seconded the motion. The motion carried on a vote of 7-0.
- 4. Board Member Abell made a motion to recommend to Council approval of the Barton Hills School Park Conceptual Master Plan. Board Member Osgood seconded the motion. The motion carried on a vote of 7-0.
- 5. Recommend to Council the approval of the planting plans at Butler Shores Park for the Zilker Lofts Project. ITEM POSTPONED TO FEBRUARY
- 6. Recommend to Council an acceptable placement of the Stephen F. Austin Statue. WITHDRAWN
