A. St. Edward's University, 3001 South Congress Avenue

Proposal: Restore the main entry porch of Holy Cross Hall.

Amount requested: \$4,500

MOTION: Recommend approval of the grant in the full amount. Vote: 3-0.

B. Paramount Theater, 713 Congress Avenue

Proposal: Façade restoration.

Amount requested: \$47,000

MOTION: Recommend approval of the grant in the full amount with the condition that the applicant obtain a Certificate of Appropriateness from the Historic Landmark Commission for the work proposed. Vote: 3-0.

C. State Theater, 719 Congress Avenue

Proposal: Restore the neon blade sign.

Amount requested: \$47,000

MOTION: Recommend approval of the grant in the full amount with the condition that the applicant obtain a Certificate of Appropriateness from the Historic Landmark Commission for the work proposed. Vote: 3-0.

D. Mayfield Park, City of Austin, 3505 W. 35th Street

Proposal: Restore the garden sheds by cleaning and replacing damaged or rotten wood siding, re-glazing windows, repairing window and door frames, and improving drainage.

Amount requested: \$30,540.

MOTION: Recommend denial of the application at this time due to outstanding grant-funded projects by the applicant. Vote: 3-0.
