The 2013 Miscellaneous Streets Slurry Seal and Micro-Surfacing project will provide preventive maintenance for selected neighborhood streets across the City of Austin. This project includes the application of emulsified asphalt slurry seal and micro-surfacing to 60 lane miles of roadway. Any crack sealing and minor surface patching that are required to repair the streets in preparation for the slurry seal application are included in the contract.

An alternate to the contract will be included for resurfacing and restriping of an additional 18 lane miles for the implementation of bicycle facilities on various streets in downtown Austin. This portion of the project is being sponsored by the Neighborhood Connectivity Division of Public Works. Due to schedule and budget risks associated with coordination of this work, a 10% contingency for the Alternate Bid contribution to this project has been included to allow for the expeditious processing of any change orders.

The contract allows 90 working days for completion of this project. This project is located on various streets in the downtown area of the City of Austin and is managed by the Public Works Department.
