Authorize award and execution of a 36-month requirements supply contract with VULCAN INC., to provide prefabricated traffic signs for the Transportation Department, in an estimated amount not to exceed \$975,000, with three 12-month extension options in estimated amounts not to exceed \$325,000 for each extension option, for a total estimated contract amount not to exceed \$1,950,000.

Amount and Source of Funding

Funding in the amount of \$135,417 is available in the Fiscal Year 2012-2013 Operating Budget of the Transportation Department. Funding for the remaining 31 months of the original contract period and extension options is contingent upon available funding in future budgets.

Additional Backup Information

This contract is for the purchase of prefabricated traffic signs for the Transportation Department. These signs are used by the Signs Program within the Signs and Markings Division to replace old and missing traffic signs citywide. The useful life of a traffic sign is approximately ten years. The most frequently maintained are stop signs and regulatory signs including speed limit and parking restrictions. Traffic signs maintenance is important as a means of reducing day and nighttime crash rates. Signs that have sufficient retro reflectivity during nighttime conditions are especially beneficial to older road users. Safe and efficient roadways are a benefit to monitoring the health and viability of a community. In addition, the Manual of Uniform Traffic Control Devices (MUTCD) now requires that agencies maintain traffic signs to a set of minimum levels.
