Additional Backup Information

This project will construct approximately 450 linear feet of a 10-foot wide concrete trail including a 180-foot bridge from Furness Drive to Park Plaza Drive across Little Walnut Creek. This project will complete a critical missing piece in the pedestrian and bicycle network in northeast Austin. It will also provide a safe route to school for students of Hart Elementary School.

Significant public outreach and communication efforts occurred through the City of Austin Neighborhood Planning process in which the neighborhood and the City were engaged for approximately 3 years (2008-2011) with extensive discussion about this project, area transportation in general, and other matters of importance to the area. As a result of these meetings, NCD worked with the Austin Police Department to apply "Crime Prevention Through Environmental Design" (CPTED) techniques to the project. This exercise resulted in redesigning the bridge abutments as well as adding lighting to the project. The Neighborhood Association has met with City staff to communicate neighborhood concerns and continues to provide updates on the anticipated construction schedule. The surrounding community is aware of the project and will receive updated communications throughout construction.

Due to the potential for changes, a 10% contingency is funding has been included to allow for the expeditious processing of any change orders. The contract allows 210 calendar days for completion of this project. This project is located within zip code 78753 and is managed by the Public Works Department.
