GENERAL DESCRIPTION OF SURROUNDING AREA

LOCATED IN CBD AMONG OTHER BARS, RESTAURANTS AND SMALL BUSINESSES. HARD REFLECTIVE SURFACES, STREETS AND BUILDINGS.

IMPACT ON RESIDENTIAL / ADDITIONAL RESTRICTIONS

IN EXTREMEMLY CLOSE PROXIMITY TO PRE-EXSISTING RESIDENTIAL CONDO UNITS. NUMEROUS RESIDENTS HAVE EXPRESSED STRONG OPPOSITION TO THIS PERMIT APPLICATION. UNDER SECTION 9-2-53-(C), CODE PROHIBITS DENIAL OF AN INTIAL PERMIT FOR AN OUTDOOR MUSIC VENUE, LOCATED WITHIN THE FOOTPRINT OF A RESTAURANT (GENERAL) USE, UNDER SECTION 25-2-808. DUE TO THIS CODE PROVISION, OUR OFFICE RECOMMENDS ISSUING THIS PERMIT SUBJECT TO A 30 DAY REVIEW, DURING WHICH TIME MUSIC OFFICE STAFF WILL CONDUCT COMPREHENSIVE SOUND TESTING TO DETERMINE ANY NECESSARY CONDITIONS (RESTRICTED HOURS, SOUND SYSTEM MAXIMUM, SOUND LEVEL MAXIMUM, REQUIRED SOUND MITIGATION) REGARDING THIS INITIAL OMV PERMIT APPLICATION. GIVEN OUR CONCERNS REGARDING PREVIOUS COMPLAINTS FROM RESIDENTS WE RECOMMEND OUTDOOR SOUND TO BE LIMITED TO THURSDAY, FRIDAY AND SATURDAY 4:00-9:00PM. OUR OFFICE WILL COORDINATE WITH THE DEDICATED APD SOUND OFFICER TO MONITOR SOUND LEVELS AT A MORE FREQUENT INTERVAL AT THIS LOCATION. APPROPRIATE LOW VOLUME SINGER-SONGWRITER STYLE ACTS ARE TO BE LOCATED ON EITHER FRONT OR BACK PORCH, BUT NOT AT THE SAME TIME.

UPDATED ON 4-22-13. BASED ON SOUND TESTING CONDUCTED BY THE MUSIC OFFICE AND APD SOUND OFFICER ON 4-16-13, THE MUSIC OFFICE RECOMMENDS REMOVAL OF ALL SPEAKERS ON THE BACK PATIO (BY 5-3-13) AND NO PERFORMANCES ON BACK PATIO. ALSO RECOMMENDED ARE RESTRICTED DAYS AND HOURS OF FRONT PORCH PERFORMANCES. (WE HAVE OMMITTED PREVIOUS SECTIONS WITH EXTENDED SPRING FESTIVAL ALLOWANCE RECOMMENDATIONS). ALL DOORS AND WINDOWS MUST BE KEPT CLOSED DURING INDOOR SOUND AMPLIFICATION, AS THE SOUND (BASS IN PARTICULAR) INTRUDES AND NEGATIVELY IMPACTS THE NEARBY RESIDENCES.

TYPE 1 OR TYPE 2 SOUND METER MUST BE ON PREMISIS AND AVAILIBLE FOR USE AND INSPECTION.
