Authorize award and execution of a 24-month requirements supply contract with TEXAS LEHIGH CEMENT COMPANY LP, to provide Type 1 Hydraulic Cement for the Public Works Department, in an estimated amount not to exceed \$350,000, with two 12-month extension options in estimated amounts not to exceed \$175,000 for each extension option, for a total estimated contract amount not to exceed \$700,000.

Amount and Source of Funding

Funding in the amount of \$58,334 is available in the Fiscal Year 2012-2013 Operating Budget of the Public Works Department. Funding for the remaining 32 months of the original contract period and extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information

This contract is for the supply of Type 1 Hydraulic Cement for Street and Bridge Operations of Public Works. The cement is a component required to produce fresh concrete which will allow the Street and Bridge Operations to make specific amounts of concrete needed on a job site, with virtually no waste of material. This material is needed to produce concrete for the repair of City sidewalks, curbs, gutters, and driveways. The Street and Bridge Operations recently purchased their own silo to hold the dry cement, and currently have four volumetric concrete trucks that are capable of mixing various amounts of concrete at desired locations once they have been identified.
