

# AUSTIN CITY COUNCIL MINUTES

WORK SESSION MEETING TUESDAY, MAY 21, 2013

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, May 21, 2013, City Hall at 301 W. Second Street, Austin, Texas.

Mayor Lee Leffingwell called the meeting to order at 9:07 a.m.

Mayor Lee Leffingwell recessed the Council Meeting to go into Executive Session at 9:08 a.m.

### **EXECUTIVE SESSION**

The City Council went into Executive Session, pursuant to Chapter 551 of the Texas Government Code, to receive advice from Legal Counsel, to discuss matters of land acquisition, litigation, and personnel matters as specifically listed on this agenda and to receive advice from Legal Counsel regarding any other item on this agenda.
