PETITION OPPOSING thinkEAST

Dear Austin City Council Members:

We are the immediately impacted neighbors of the thinkEAST project (NPA-2012-0016.01.SH and C814-2012-0128.SH) proposed for our small community of approximately 50 houses in East Austin.

We are writing this urgent letter to you requesting that this zoning request be denied or that the hearing to approve or deny the request before you today be postponed to a time when everyone in our neighborhood can better understand the project's impacts on our community and future.

The project that we were told about on November 26, 2012, is vastly different than the project before you today. We were told at the community meeting that the project was 280 units of housing and mixed use retail and office space, however the project has drastically changed, and just last week (May 28, 2013) we learned that the project now is 442 units.

Additionally, the current proposal is NOT what the Neighborhood Planning Contact Team agreed to support in their letter dated July 29, 2013. The letter of support issued by the Neighborhood Planning 'Contact Team specifically reads "Support the Pre-Application for PUD zoning for the above mentioned project with the following conditions: 1. thinkEAST agrees to adhere, to the fullest extent reasonable and possible, to the basic concept and design set forth in the PUD Pre-Application."

The PUD Pre-Application for thinkEAST only includes 280 units of housing and other mixed uses. We are confident that you will agree that an increase of 158% of units (162 additional units total) does not comply with their letter of support and "adhering, to the fullest extent reasonable and possible, to the basic concept and design set forth in the PUD Pre-Application."

We the neighbors have not had the appropriate time to consider the increased density and/or work with everyone involved to reach a consensus or agreement. We feel that we have been purposefully left out of the project and that the developer has willfully deceived everyone involved or impacted by the proposal.

We ask you to please issue an immediate denial of the proposal or submit to our request for a postponement of the hearing and your decision to a later date. The biggest harm and injury to our neighborhood will come from rushing through a project that negatively impacts our small well established community and destroys the delicate fabric of the neighborhood that we have all jointly built our lives around.
