This contract is for the supply of liquid emulsion polymer for the Austin Water Utility (AWU) and will be ordered on an as needed basis. The polymer will be delivered to and used by the AWU, Hornsby Bend Biosolids Management Facility, which handles the treatment and reuse of all City bio-solids (sewage sludge) from the two major wastewater treatment plants and several small package plants around the City.

Polymer is used in the treatment process to dewater and thicken sludge at the facility. After the sludge has been properly treated, it is either spread over 1,200 acres of City-owned open land currently planted in Costal Bermuda grass, land applied at an off-site location or it is composted and sold as Dillo Dirt. This is an environmentally safe method of removing sludge from the facility.
