<p>The Council will conduct a public hearing to consider the proposed assessments on the Public Improvement District (PID) for the Estancia Hill Country project. This area includes approximately 600 acres located in southern Travis County west of IH 35 South approximately eight-tenths of a mile south of the intersection IH 35 South and Onion Creek Parkway. This area is currently undeveloped, and the developer's plans for this site include a mixed-use project with residential and commercial land uses.</p> <p>On June 6, 2013, City Council approved authorizing creation of a PID, in response to a petition by the property owners, a state law prerequisite to creation of a PID.</p> <p>The PID will provide a financing mechanism through the apportionment, levying and collection of PID assessments for the construction, ownership, and maintenance of certain improvements to support the planned community and for the issuance of bonds to finance certain improvements.</p>
