# HISTORIC LANDMARK COMMISSION JUNE 24, 2013 DEMOLITION AND RELOCATION PERMITS HDP-2013-0394 1313 KENWOOD AVENUE

#### **PROPOSAL**

Completely remodel the façade of a ca. 1930 house and add an addition to the rear.

### ARCHITECTURE

One-story, rectangular-plan Tudor Revival-styled frame house with a prominent cat-slide gable composing the right side of the front façade, and a front-gabled entryway with a round-arched opening, composing the left side; a massive, brick, battered exterior chimney separates the two components of the façade. Fenestration consists of single and paired 1:1 wood-frame, wood-sash windows with 9:1 wooden screens, and pair of diamond-paned casement windows to the right of the brick chimney in the "cat-slide" section of the gable.

#### RESEARCH


The house appears to have been built around 1930. The first occupants were Carl and Lois Raschke, who lived here until around 1936. He was the office manager at Goodyear Tire and Rubber Company. From that time forward, the house has been a rental property, occupied by a series of tenants with remarkably heavy turnover for the style, size, and location of this house. The tenants included the manager of the Walgreen Drug Company on Congress Avenue, a salesman, a farmer, the cashier at the Night Hawk Restaurant, and a janitor at the Austin State Hospital.

#### STAFF COMMENTS

The house appears in the 1984 Comprehensive Cultural Resources Survey, but without a priority for research.

#### STAFF RECOMMENDATION

Encourage the applicant to re-consider the plans to transform the style and appearance of this house. While staff does not believe that the house has sufficient historical significance to warrant individual designation as a historic landmark, it is a truly excellent example of the Tudor Revival style, which typifies residential construction in Travis Heights, a potential historic district. Further, this house is a wooden Tudor Revival house, which is relatively rare; most Tudor Revival houses in Austin were clad in brick. However, the Commission may release the permit, as this house is neither a historic landmark nor within a historic district. If the demolition permit is approved, then staff recommends the completion of a City of Austin documentation package prior to release of the permit.






CASE#: HDP-2013-0394 LOCATION: 1313 Kenwood Avenue






