This project is located along Todd Lane from Ben White Boulevard to Saint Elmo Road. It will provide 8 feet wide buffered bike lanes, 10 feet wide sidewalks, seven rain gardens, two bio filtration/sedimentation ponds, and a single lane modern roundabout. Also included are 4,230 linear feet of new water line with appurtenances, nine waste water manhole adjustments, and 3,715 linear feet of storm drainage line. Two neighborhood associations and numerous individual property owners were contacted and updated on the project.

The single-lane modern roundabout and innovative water quality control features minimized the need for real estate acquisition and resulted in significant construction cost savings.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right-of-way, a 5% contingency in funding has been included to allow for the expeditious processing of any change orders.

The contract allows 540 calendar days for completion of this project. This project is located within zip code 78702 and is managed by the Public Works Department.
