**PROPOSAL**

---

Demolish a ca. 1938 house and a ca. 1939 garage apartment.

---

**ARCHITECTURE**

---

The main house is a two-story, rectangular-plan, side-gabled frame house with minimal Colonial Revival detailing, in the form of a broken swan's neck pediment and pilasters at the front door. The house has an asymmetrical composition, with the front entry offset to the right of the center of the façade; fenestration is single and paired 1:1. The garage apartment is a two-story, rectangular-plan hipped-roof frame building with single and paired 1:1 fenestration; the entry is offset to the left of the first floor, facing the street. Both buildings have synthetic siding.

**RESEARCH**

---

Research indicates that there was a ca. 1901 house on this site, which was also a two-story house with a two-story front porch. Leon Street is not shown as a platted street on the 1900 Sanborn map, but the ca. 1901 house appears on both the 1922 and 1935 Sanborn maps. The attached occupancy history for this property includes that structure, in the very unlikely event that the current house is a remodeling of the ca. 1901 house. The ca. 1901 house was owned and occupied by Charles S. Kellum and his wife, Martha. Charles Kellum was a barber, who started off in the Driskill Hotel Barber Shop, and the Avenue Hotel Barber Shop before opening his own barber shop around 1914. He had several locations for his shop, including 1005 Congress Avenue (1914), 1504 Lavaca Street (1916 – 1921), 2107 Speedway (1921-1925), and 112 W. 5<sup>th</sup> Street (1925 – 1935). He and Martha lived here until around 1938, when it is believed that the current house was constructed. The Kellums moved to an area north of the city in their later years; Charles Kellum died in 1947; his obituary mentions that he was a past president of the Austin Trades Council.

The current configuration of the house is reflected on the 1961 Sanborn map, which also shows the ca. 1939 garage apartment, for which there is a building permit. The style of the garage apartment differs somewhat from the style of the house, especially in roof form, which leads to a possible conclusion that the main house pre-dates the garage apartment, and could possibly be a massive remodel of the original ca. 1901 house built by the Kellums. There are no separate listings for the garage apartment in the city directories, so it is unknown who occupied that building. The main house was shown as a rental in the 1939 city directory; it was owned by trucker Claude R. Meeks and his wife Mary in 1941, and by tile contractor William E. Trafton and his wife, Ktie in 1944-45. By 1947, the house was occupied by Annie N. Baker, the widow of Dr. E.B. Baker of Hidalgo County. Annie Baker was a nurse, and moved to Austin from the Valley in the mid-1940s. She lived here until the mid-1950s, when the house was purchased by Only True Scarborough, and his wife, Melva. Scarborough was the son of Milam County farmers, who entered the painting and paper-hanging trades. Prior to living in this house in Austin, he and Melva had lived in Taft, Texas, El Campo, Texas, and Shreveport, Louisiana. He died in Tarrant County in 1975; he and Melva are buried there. After the Scarboroughs' residency in the house, it became an apartment building, which it remains to this day.

**STAFF COMMENTS**

---

The house appears in the Comprehensive Cultural Resources Survey (1984) but without a priority ranking for research.

**STAFF RECOMMENDATION**

---

Release the permit. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark, and has had several non-historic alterations, including the application of synthetic siding, that do not warrant the completion of a documentation package.

### **Charles S. and Martha Kellum (ca. 1901 – ca. 1937)**

Charles S. and Martha Kellum appear in the 1940 U.S. Census as the owners of a house in rural Travis County; their house was worth \$5,000. Charles S. Kellum was then 73, had been born in Georgia, and had no occupation listed. Martha Kellum was then 64, and had been born in Germany. With them lived their son, Thomas, 43, who had been born in Texas, and was a lawyer in private practice. The 1930 U.S. Census shows Charles and Martha Kellum as the owners of this house, which was worth \$9,000. Charles Kellum was a barber with his own shop. With them lived their children: Thomas, 33, a lawyer in a private office; Viola, 24, a public school teacher; Mary E., 20, a university student; and Ruth, 13, a public school student. The 1920 U.S. Census also shows the Kellums as the owners of this house. Charles is listed as a barber; son Thomas is listed as a stenographer in a law office; daughter Marguerite, 21, was a teacher; the four younger daughters, Leona, 16, Viola, 14, Mary E., 9, and Ruth K., 3, had no occupations listed. The 1910 U.S. Census shows the family at this same address, and shows that Mary E. was listed as Mamie. There was another son, Willfred, who was 9 at the time of the census report. Charles Kellum was a barber. The 1900 U.S. Census shows the family living at 1701 Brazos Street. Charles Kellum is listed as a barber.

#### **CHARLES S. KELLUM**

Charles S. Kellum, 81, died at his home north of Austin Friday. He is survived by his wife, Mrs. Martha A. Kellum; one son, Colonel T. B. Kellum of Austin; five daughters, Mrs. W. E. Hollingsworth of Beaumont, Mrs. George A. Harris of Houston, Mrs. Donald Redmond of Kingsville, Mrs. Eugene P. Crowell of Plainview and Mrs. Shelby T. Crosby of Pharr; one sister, Mrs. Milburn W. White of San Antonio; and one brother, Joe T. Kellum of Bastrop. He has been a resident of Austin for the past 45 years, a good

part of which he operated his own barber shop here. He was past president of the Austin Trades Council. Funeral services will be conducted at the Weed-Corley Funeral Home at 4:30 p. m. Sunday by Dr. Edmund Heinsohn and burial will be in Oakwood Cemetery.

The 1940 U.S. Census shows Dr. E.B. and Annie Baker living outside Edcouch in Hidalgo County, Texas. Dr. E.B. Baker was then 68, had been born in Louisiana, and was a doctor with a private practice. Annie Baker was then 54, had been born in South Carolina, and was a nurse with a private practice. They had a son, E.B., Jr., 14, who had been born in Texas. The 1930 U.S. Census shows the Baker family living in a rented house in rural Hidalgo County. E.B. Baker is listed as a doctor of medicine; Anna had no occupation listed.

### **Annie N. Baker**

**Annie N. Baker, age 98, died Wednesday evening after a lengthy illness.**

**A native of South Carolina, Mrs. Baker served as a nurse with the American Red Cross during World War I. She moved to Texas in 1922, and to Austin in 1946. She was an active member of the University Methodist Church until her illness.**

**Mrs. Baker is survived by one son, E.B. Baker of Austin; and two nieces.**

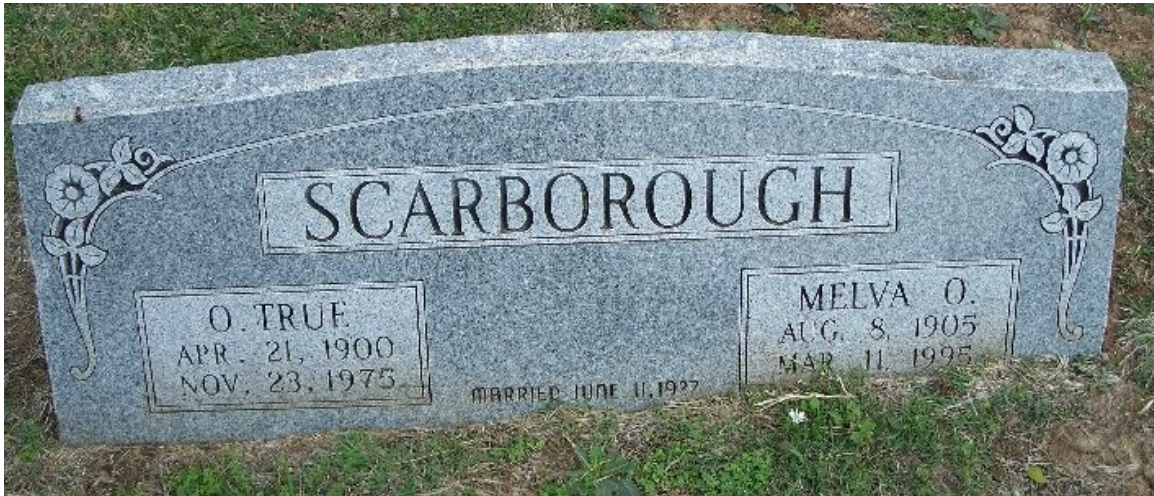

### **O. True and Melva Scarborough (ca. 1957 – ca 1975)**

Only T. and Melva Scarborough appear in the 1930 U.S. Census for Taft, San Patricio County, Texas. They rented their house there. He was then 29, had been born in Texas, and was a building painter. Melva Scarborough was then 24 and had been born in Texas. She had no occupation listed. They had a 1-year old daughter, Julia.

O. True and Melva Scarborough appear in the 1940 U.S. Census for Shreveport, Louisiana, where they were renting a house. O. True was a paper hanger and painter; Melva had no occupation listed. The census reports shows that they had lived in El Campo, Texas in 1935. In addition to Julia, they had two younger children: James, 4, had been born in Texas; and Jerry, 1, had been born in Louisiana.

O. True Scarborough died in Tarrant County in 1975, and is buried there. Melva Scarborough died in 1995.

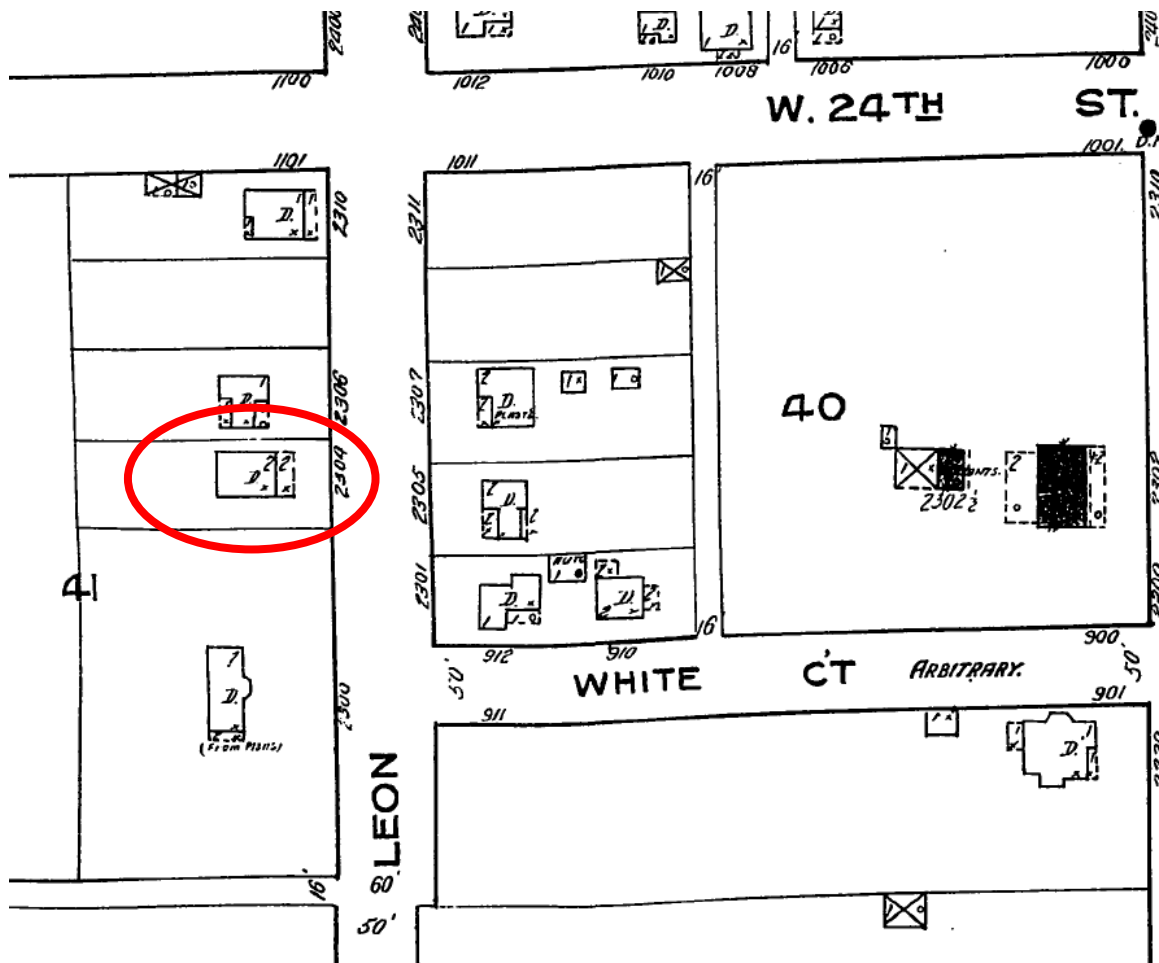

Building permit to Mrs. Wallace for the construction of the garage apartment (1939)



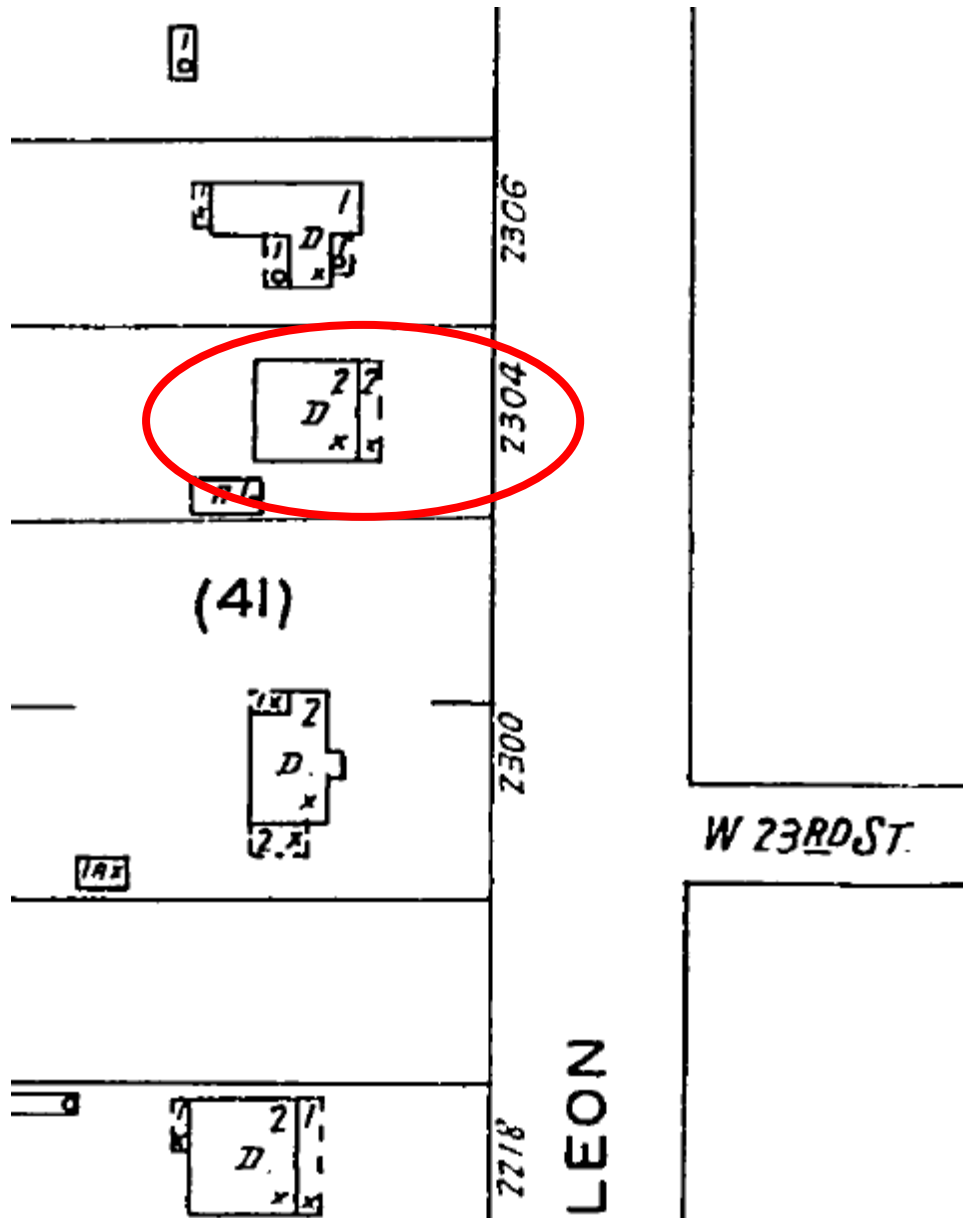


Leon Street is not shown on the 1900 Sanborn map of the neighborhood.

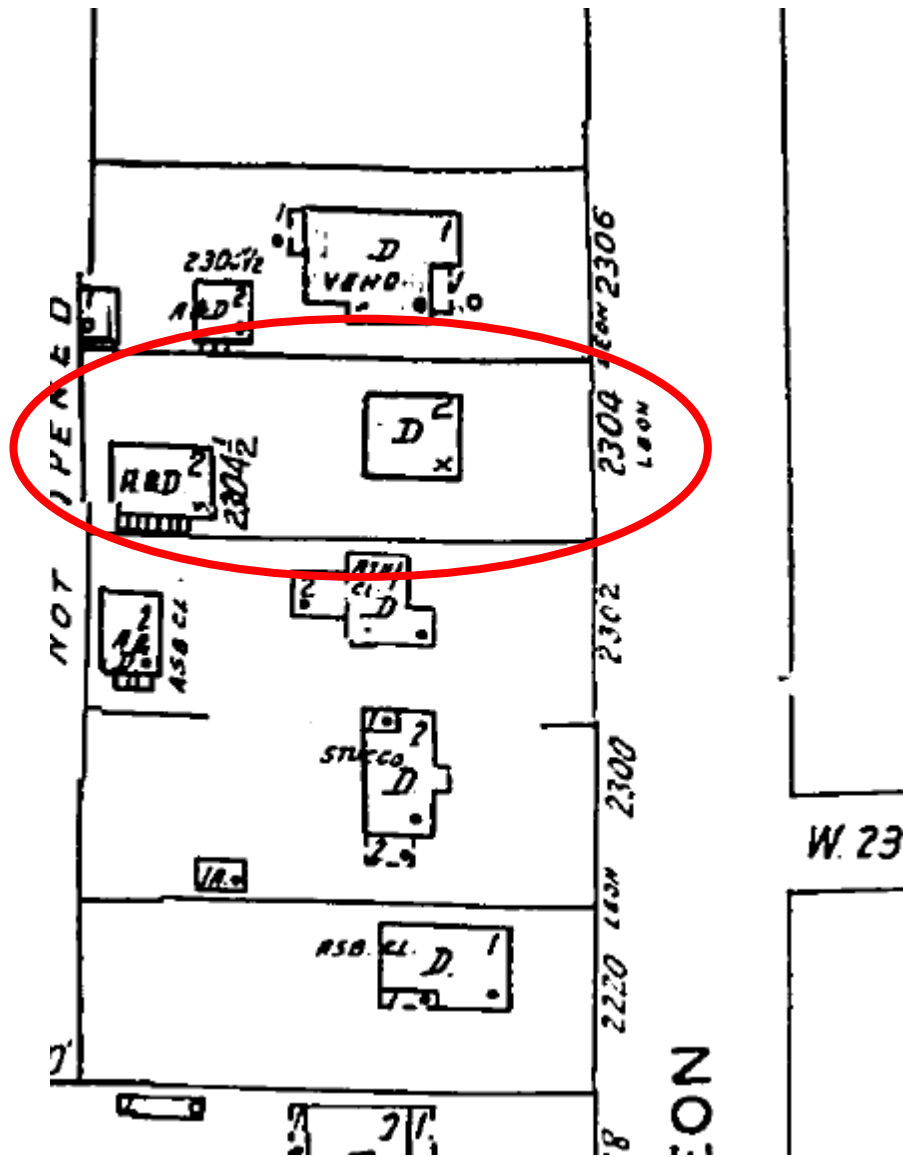


The house appears as a two-story house with a two-story front porch on the 1922 Sanborn map.
