1. CITIZENS COMMUNICATIONS

2. APPROVAL OF MINUTES

4. NEW BUSINESS

- a. Resolution from Susana Almanza, Director of People Organized in Defense of Earth and Her Resources (PODER) regarding urban farms in East Austin.
 - i. Eleven citizens spoke on the current zoning in East Austin allowing urban farms.
 - ii. Item was tabled for discussion at a later meeting. Commissioner Cortez Motion, Commissioner Brenner seconded on a 6-0 vote. Commissioner Reynolds was absent.

- b. Resolution from Human Rights Campaign regarding the City of Austin's "Municipal Quality Index" rating.
 - i. Lauren Zurbrugg, Human Rights Campaign, spoke on the necessity of Austin to strive to score a full 100 points on the Municipal Quality Index.
 - ii. Recommendation adopting full support of City Council directing the City Manager to take proactive steps to score a full 100 points was approved on a 4-2 vote, Commissioner Davis motion, Commissioner Brenner second. Commission member Reynolds was absent.

- a. 2013 goals were divided into three categories: community discussion, outreach project and improvement of internal processes.
 - i. Community discussion will change to meeting with stakeholders.
