This project provides necessary bridge maintenance and repair to 13 bridges throughout the city. The work includes channel scour remediation; curb and gutter repair; driveway, sidewalk and sidewalk ramp repair; metal rail repair; joint sealing; asphalt milling and overlay; and striping on the selected bridges. The work includes all required traffic control measures.

The 13 bridges affected are:

Field observations indicate unknown subsurface issues, the magnitude of which cannot be estimated until the work begins; therefore a 10% contingency in funding has been included to allow for the expeditious processing of any change orders.

The contract allows 120 calendar days for final completion of this project. This project is located within the following zip codes: 78741, 78744, 78727, 78701, 78723, 78730, and 78750. This project is managed by the Public Works Department.
