| The purpose of the Ryan White Part A HIV Emergency Relief Project is to provide support to clients who have been affected by HIV/AIDS and who reside in the five-county Austin Transitional Grant Area (Austin TGA) that includes Bastrop, Caldwell, Hays, Travis, and Williamson counties. The program's goal is to assure access to primary medical care and medications as well as to provide critical support services necessary to maintain individuals in the system of HIV care. These services are provided in partnership with local organizations including AIDS Services of Austin, Inc., a provider of multiple core and supportive services including Health Insurance Premium, Food Bank and Oral |  |                                  |       |                    |       |     |

Health services, Project Transitions, Inc., provider of Hospice services, The Wright House Wellness Center, and Community Action, Inc. providers of Medical and Non-Medical Case Management services.

Other HIV client services are been provided by various HIV providers in the community as outlined in the April 5th, 2012 City Council authorization.

On June 18, 2013, the City of Austin received its second Notice of Award (NOA) for the Austin TGA from the U.S. Department of Health and Human Services for \$4,024,795. On June 25, 2013 the Austin Area Comprehensive HIV Planning Council, by its legislatively mandated responsibility of prioritizing and allocating Part A service funds, allocated Part A funds to core and supportive services based on demonstrated need for these services.

This grant provides direct financial assistance to communities most severely affected by the HIV epidemic. The \$167,999 of additional funds are being utilize by AIDS Services of Austin, Inc., for additional dental services. Project Transitions, Inc. will provide additional hospice services and Community Action and The Wright House Wellness Center will provide additional case management services.

Through WRIGHT HOUSE WELLNESS CENTER, approximately 8 eligible clients will receive approximately 418 units of Non-Medical Case Management Tier1 non-MAI. One unit=15 minutes with client

Through PROJECT TRANSITIONS, approximately 14 eligible clients will receive approximately 273 units of Hospice Services. One unit=one day in hospice
