## Subject

Authorize award and execution of a 36-month requirements supply contract with MCCAIN INC., to provide traffic signal heads for the Transportation Department in an amount not to exceed \$240,000, with three 12-month extension options in an amount not to exceed \$80,000 per extension option, for a total contract amount not to exceed \$480,000.

## Amount and Source of Funding

Funding in the amount of \$13,334 is available in the Fiscal Year 2012-2013 Operating Budget of the Transportation Department. Funding for the remaining 34 months of the original contract period and extension options is contingent upon available funding in future budgets.
