6 **AN ORDINANCE AMENDING CHAPTER 2-5 OF THE CITY CODE SETTING**  
7 **A BEGINNING DATE FOR THE REGULAR TERM OF A COUNCIL MEMBER;**  
8 **PROVIDING AN END DATE FOR THE TERMS OF SITTING COUNCIL**  
9 **MEMBERS; AND PROVIDING A METHOD FOR STAGGERING THE TERMS**  
10 **OF COUNCIL MEMBERS ELECTED FROM DISTRICTS.**

12 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**  
13

14 **PART 1.** City Code Chapter 2-5 (*Council Action, Meeting Procedures, Public Hearings,*  
15 *and Appeals*) is amended by adding a new Article 4 to read as follows:

16 ***ARTICLE 4. COUNCIL TERMS***

17 **§ 2-5-71 Regular Term of a Councilmember.**

- 18 (A) This section applies to a councilmember elected in the City general election  
19 held on November 4, 2014, and to a councilmember elected to a full term at  
20 each City general election thereafter. The general election includes the  
21 subsequent runoff election, if any.
- 22 (B) The regular term of a councilmember begins on the 15<sup>th</sup> day of December  
23 following the City general election.

24 **PART 2.** The caption of City Code Chapter 2-5 is amended to read: Council Action,  
25 Meeting Procedures, Public Hearings, ~~and~~ Appeals, and Terms.

26 **PART 3.** Pursuant to Article III, Section 2(A) of the City Charter, the term of each  
27 council member serving on the effective date of this ordinance ends on December 15,  
28 2014 when the new council members elected in the 2014 general election assume office.  
29 As soon as practicable after assuming office after the 2014 general election, the council  
30 members elected from council districts shall divide themselves into two classes by  
31 drawing lots. Class One shall consist of five council members who shall serve a two-year  
32 term. Class Two shall consist of five council members who shall serve a four-year term.  
33 Thereafter, unless elected to fill a vacancy, each council member shall be elected to a  
34 four-year term.
