**PROPOSAL**

---

Demolish a ca. 1950 house.

**ARCHITECTURE**

---

One-story, rectangular-plan, side-gabled, stone-veneered and wood-sided frame ranch house with a partial-width, flat roofed independent porch; metal-framed multi-light picture and casement windows.

**RESEARCH**

---

The house was built in 1950 for Edgar and Percy Jackson, who moved here from 3300 Bonnie Road. Edgar Jackson was a real estate agent, who also served on the City Planning Commission from 1959 to 1967. After his death in 1978, Percy, who had taught at Sam Houston State College and Lamar Junior High School here in Austin, continued to live in the house until her death in 1991.

---

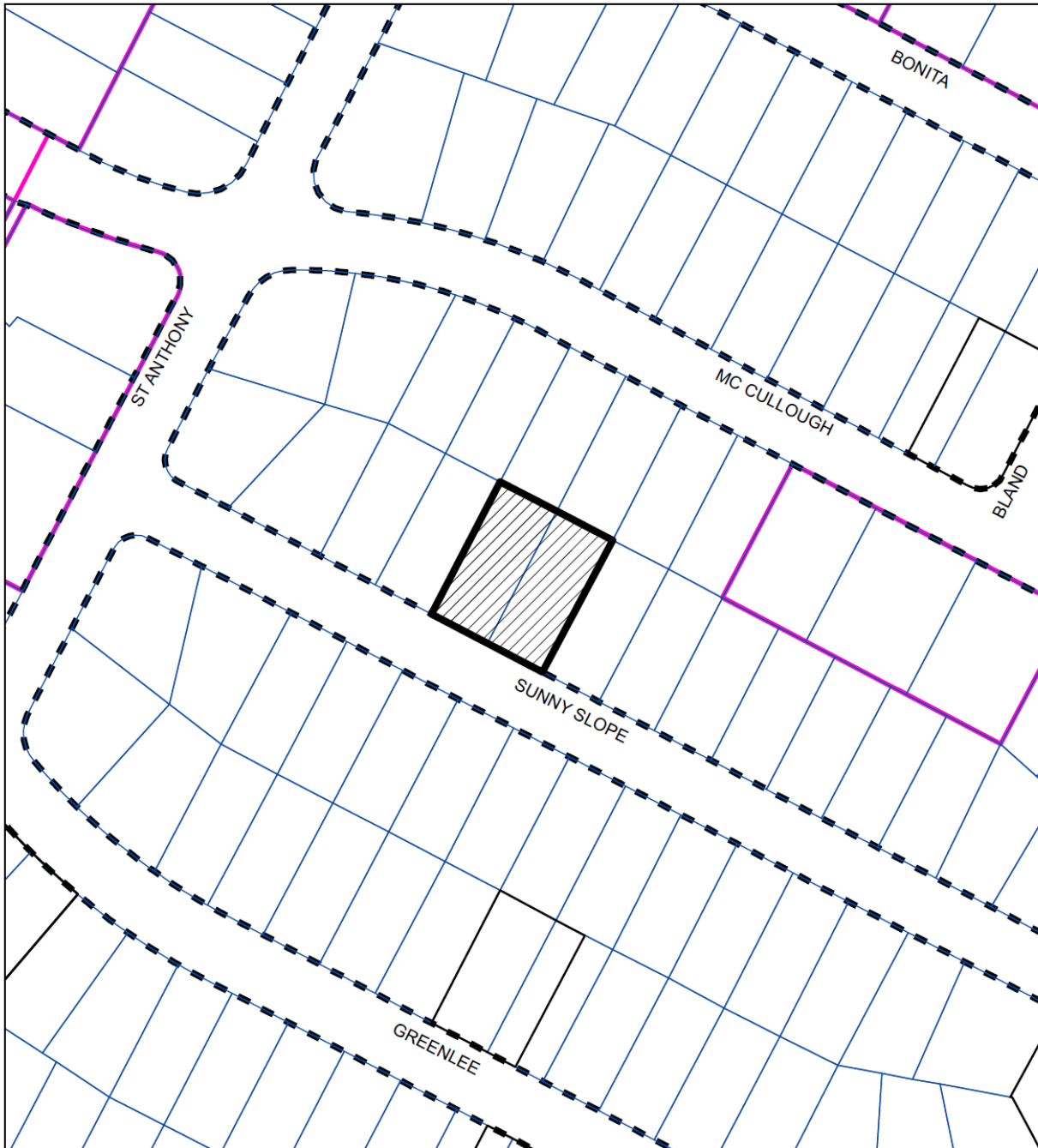
The house is beyond the bounds of any City survey.

**STAFF RECOMMENDATION**

---

Recommend relocation over demolition, but release the permit after completion of a City of Austin Documentation Package consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house is a very good example of a builder-constructed mid-century ranch house.

## **Percy Lee Putnam Jackson**

Percy Lee Putnam Jackson, age 85, of Austin, died Friday.

Mrs. Jackson, a graduate of Smithville High School, earned a B.A. from Baylor University and an M.A. from Peabody College in Nashville, Tennessee. After teaching in Corpus Christi, she was an associate professor at Sam Houston State Teacher's College, and retired from Lamar Junior High School in 1971 after many years in the AISD.

In addition, she was an editor of the Texas State Mental Health Magazine, founder of the Y-Teen Club at O'Henry Junior High School, a longtime supporter of the Austin Ballet Society, and active in the Auxiliary of St. David's Hospital and the Church of the Good Shepherd.

Mrs. Jackson, the widow of realtor, Edgar Earl Jackson, is survived by her daughter and son-in-law, Suzanne and Kenneth Nash and granddaughter, Anne Jennifer Nash of Pittsford, New York.

Services will be held at 10:00 AM, Monday, August 26, 1991, in the Episcopal Church of the Good Shepherd with the Reverend Anne Hoey officiating. Burial will be in the Oak Hill Cemetery in Smithville at 12:00 Noon, Monday.
