



**DOWNTOWN COMMISSION

**REGULAR MEETING  
WEDNESDAY, JULY 17, 2013**

The Downtown Commission convened in a meeting on Wednesday, July 17, 2013, at 301 W. 2nd St. in Austin, Texas.

Chair Bart Whatley called the meeting to order at 5:48 p.m.

The Commission received a presentation from Bill Brice, Downtown Austin Alliance, Chief Raul Mungia, Austin Police Department, Pete Valdez, Front Steps, and Mitchell Gibbs, Downtown Austin Community Court.

A Motion to support the request from APD, Downtown Austin Community Court and Front Steps for FY14 budget unmet needs as presented was made by Commissioner Sher and seconded by Commissioner Galligan on a 9-0 vote, with Commissioner MacKinnon abstaining.

The Commission received a presentation from Commissioner Way.

The Commission requested that Jim Robertson, COA PDRD, attend the August meeting to discuss the Rainey Street District Plan.
