Differences Between Ordinances



Ordinance:
20130606-049

Registration

CM Spelman require registration only for repeat offenders
CM Tovo require registration for all multi-family rental properties within the pilot area for 1 year. Also requires registration for single family rental properties under certain conditions.

Ordinance:
20130606-050

Fee Assessment

CM Spelman fee assessed to repeat offenders only
CM Tovo fee assessed to all multi-family rental properties

Compliance Approach

CM Spelman reactive by including requirement for only repeat offenders
CM Tovo proactive by including requirement for all multi-family rental properties in a registration program. This approach is reactive to single family and duplex in that criteria will be set when these rental properties are required to register (which is the same as CM Spelman's direction)

Community Feedback

■ Recommendations noted below reflect feedback that was agreeable to the majority of participants:

Proactive Enforcement - A more proactive approach is needed.

Stealth Dorms - A separate resolution/ordinance should be considered address stealth dorms.

Education and Training - An educational program and training for owners, managers and tenants should be included.

Incentives - Incentives are needed for responsible property owners.

Performance Measures - Performance measures should be clearly defined.

Tenant Protection - Tenant protection should be addressed.

Transparency and Resources - An all-inclusive website should be available.

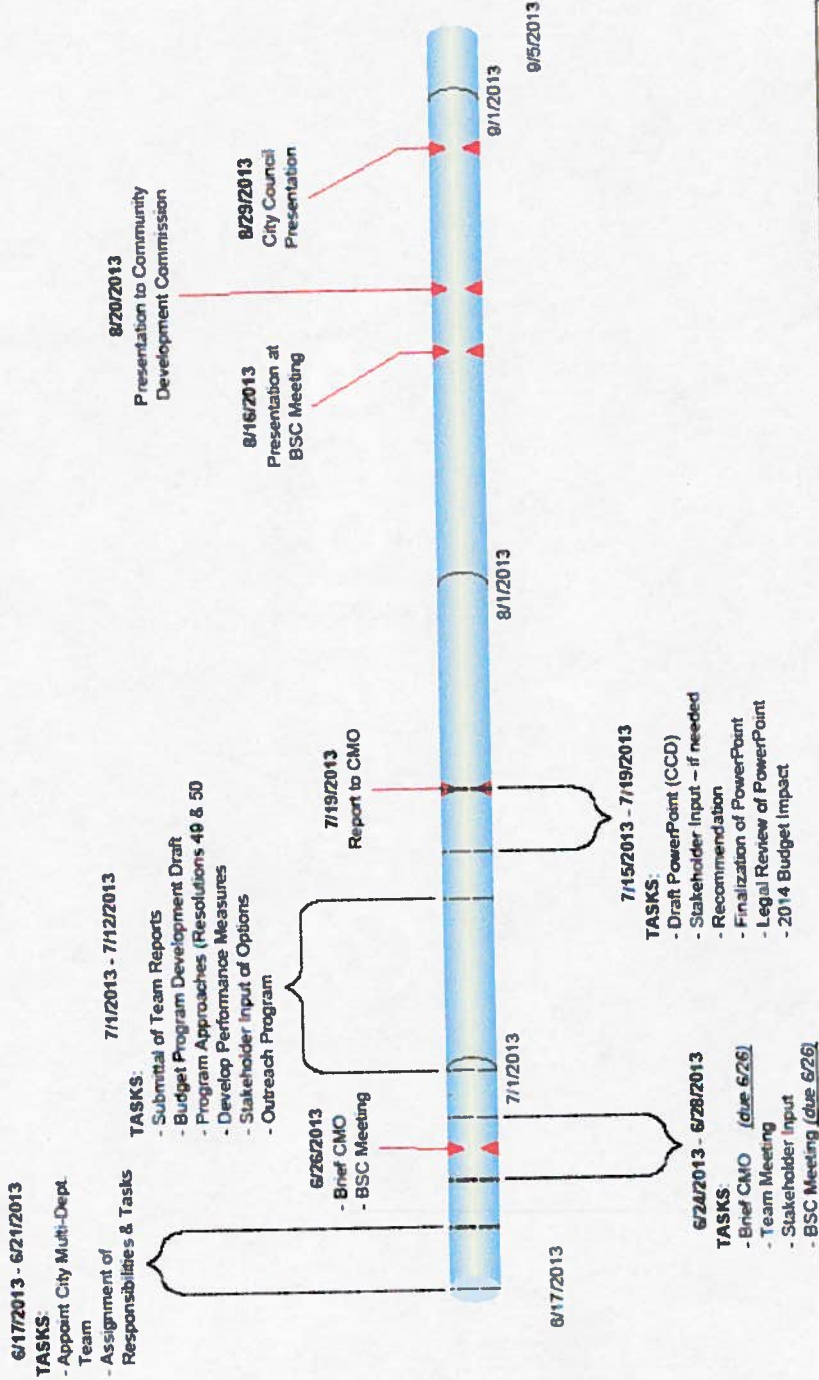
