PROPOSAL

Demolish a ca. 1937 house.

ARCHITECTURE

One-story, rectangular-plan, board-and-batten, front-gabled frame bungalow with single and paired 1:1 fenestration; the original front windows on the house have been replaced.

RESEARCH


The house was built in 1937 by Sam T. Hill as an investment property. The first occupants of the house were Henry L. and Genary Newton, who lived here together until Henry's death in 1946. Henry L. Newton had a 50-year occupational history with the City's power plant – he worked as an electrician there, then chief engineer of the power plant. According to his obituary, he helped plow the first furrow for the construction of the old Austin dam. By the time he and Genary lived in this house, he was up in years, and listings in the city directories showed him to be a watchman at the city sewer plant, while Genary had various occupations, including a laundry worker at St. Edward's University, and a matron at Brackenridge Hospital. His obituary also called him the head of the city's power plant; he rented this modest house, which seems a little incongruous with his prominence. After Henry's 1946 death, Genary Newton married Carl G. Wagner, a millman at Calcasieu Lumber Company; they lived here until Carl died in 1959; Genary's 1961 obituary noted her address on Holly Street. The house was a rental until through the 1960s and early 1970s; Joe and Flora Arismendez rented the house in the mid-1970s, then are listed as the owners of the house thereafter. Joe Arismendez was a roofer; Flora Arismendez worked as a food service worker in the public schools in her later years. Joe Arismendez died in 2002.

STAFF COMMENTS

The house appears in the Comprehensive Cultural Resources Survey (1984) but without a priority for research.

STAFF RECOMMENDATION

Encourage relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

BIOGRAPHICAL NOTES:

Henry L. and Genary Newton (ca. 1937 – ca. 1946)

H.L. and Genary Newton appear as the renters of this house in the 1940 U.S. Census report. H.L. Newton was then 72, had been born in Texas, and was a watchman for the City of Austin. Genary Newton was then 63, had been born in Texas, and had no occupation listed. With them lived their daughter, Mabel, 40, a Texas-born waitress in the university cafeteria, and her son, Charles, 9, who had been born in Texas. Mabel and Charles had lived in San Antonio in 1935. The 1930 U.S. Census shows Henry L. and Genary Newton renting a house at 200 Rio Grande Street in Austin. Henry L. Newton was an engineer in the city power plant. With them lived Genary's mother, Mollie (listed as Newton, but she was actually Mollie Collins, as shown in the 1910 U.S. Census), 73, a Texas-born widow who was listed as retired. The 1920 U.S. Census shows Henry L. and Genary Newton renting a house at 607 Henderson Street; he was a stationery engineer for the city water, light, and power plant. The 1910 U.S. Census shows Henry and Genary Newton at 301 Crockett Street, along with Genary's parents, Molly and Robert Collins. Henry is listed as an electrician in the city power plant. Neither of Genary's parents had an occupation listed.

Carl G. and Genary Wagner (ca. 1946 – ca. 1960)

After Henry L. Newton's death in 1946, Genary Newton married Carl G. Wagner, a millman at the Calcasieu Lumber Company. Carl Wagner had previously been married; his wife Nettie died in 1945. Carl G. and Nettie Wagner appear in the 1940 U.S. Census at 1504 Brackenridge Street, a house they owned. Carl G. Wagner was then 57, had been born in Germany, and was a cabinet-maker. Nettie Wagner was then 54 and had been born in Texas. They had 7 children; the two oldest boys were both employed in a cabinet shop.

Carl G. Wagner, 77. died Wednesday in a local hospital.

Wagner was a lifetime resident of Austin, and a millman at Calcasieu Lumber Company. 
