Additional Backup Information							
On August 15, 2013, the City of Austin Health and Human Services Department (HHSD) received a revised Notice of Grant Award from the U.S. Department of Health and Human Services for the Ryan White Part C Early Intervention Services Grant in the amount of \$946,572. The amount includes \$79,808 in carryover funds from FY12. The FY13 grant was reduced by five percent in order to meet HRSA's Sequestration Operating Plan.							

The current approved grant appropriation in the 2012-2013 budget is \$873,000. The requested increase of \$73,572 represents the difference between the approved grant appropriation of \$873,300 in the fiscal year 2012-2013 budget and the total grant amount awarded in 2012-2013 of \$946,572.

The additional grant funds are a result of a carryover request submitted to grantor on May 17, 2013 with the proposal to expend the funds in the 2013 grant year.

The Austin Part C Program Area proposed to use grant year 2012-2013 carryover funds for direct HIV core services such as Oral Health and Pharmaceuticals as well as supportive services such as none-medical case management.

The General Fund will not be required to contribute to this grant.
