## GENERAL MEMBERSHIP CHARACTERISTICS

- The HIV Planning Council is currently comprised of 14 voting members and 1 non-voting member. The nonvoting member represents the Mayor's office and plays a key role in presenting documents and information to the Mayor for attention and response.
- Membership applications received since last report: $\underline{1}$
- There are 14 mandated membership categories
- Four (4) membership categories are currently vacant.


## The vacant membership categories are:

- Hospital Planning Agencies or health care planning agencies
- Social Service Providers
- Grantees under subpart II of Part C
- Grantees under section 2671 , or if none are operating in the area, representatives of organizations with a history of serving children, youth, women, and families living with HIV and operating in the area


## MEMBERSHIP APPROVALS AND TERMINATIONS

- No applications are currently pending mayoral approval.


## KEY MEMBERSHIP CHARACTERISTICS

- HRSA requires $1 / 3$ (33\%) of Planning Council membership be comprised of consumers who are recipients of Ryan White Part A services. The current [unaligned] consumer membership is 35\%.
- In accordance with Planning Council bylaws, members who have a conflict of interest, as defined by local, state, and federal statute, may not exceed $1 / 3$ (33\%) of the total membership. The current percentage for members with a conflict of interest is $13 \%$.
