Additional Backup Information

In November 2010, Austin voters approved construction of the Boardwalk Trail project. Construction is approximately 57% complete and substantial completion is expected by June 2014.

The Boardwalk Trail at Lady Bird Lake will close an existing 1.2 mile gap in the trail system around the lake. Trail users are currently redirected to the sidewalk of Riverside Drive and continue on the sidewalk over IH 35. The Boardwalk Trail will consist primarily of a raised concrete trail over the lake and shore lands with trail head entrances located at key points to facilitate access.

This additional authorization will allow for design of the ADA-accessible fishing pier and associated landscaping changes, which were authorized by the 2012 Bond. Additional authorization will also include: structural engineering design changes due to unforeseen conditions during construction particularly at connecting trails; necessary field adaption of various minor structural details; and construction phase and warranty phase services.

This project is located in zip codes 78704 and 78741, and is managed by the Public Works Department.

This amendment has been approved City's Change Control Committee.
