Audit Report: AustinGO

- Audit and Finance Committee report delivered on Aug. 28
- Staff reviewed and concurred with audit findings and recommendations
- Staff highlighted distinction between Open Government Initiative and AustinGO
- Staff has responded with the following strategies for implementation





Recommendation 1: Open Government

Implement an Open Government strategic framework/plan that includes milestones and clear roles and responsibilities to effectively meet requirements of City Council resolution 20111208-074.

- Executive team to release a draft of the City of Austin Open Government Directive that outlines the implementation plan for an open government framework (Completed 8/26/2013)
- Implement governing body to oversee open government*
 - Add budget for support of open government initiatives
 - Create additional guidelines and policies, as needed, to support and promote open government strategies
 - * To begin Fall 2013 with the hiring of Chief Innovation Officer





Recommendation 2: AustinGO

The City Manager's Office should ensure that a complete web governance structure is developed, documented, implemented, and monitored to address current gaps.

- The web team will develop a comprehensive list of best practices for City of Austin websites related to branding, content standards, regulatory compliance, domain management, performance, data retention, accessibility and 3rdparty contracts. (Draft completed 9/30/13)
- The City Manager will promote an Administrative Bulletin to set in place standing controls for websites implemented for City business. Non-compliant websites will be either brought into compliance or replaced by an AustinGO site supported by the web team. (Planned for 12/16/2013 completion.)
