Additional Backup Information						
A Notice of Funding Availability was published and three agencies submitted letters of intent to compete. A competitive Request for Application process was conducted. One application was submitted. The Young Women's Christian Association (YWCA) Greater Austin submitted an application.						
Approval of this Recommendation for Council Action will authorize a contract for child care voucher services with the YWCA Greater Austin for the initial 12-month term of October 1, 2013 – September 30, 2014. The services are known as the Bridge Child Care Voucher Program. The Bridge Program provides child care to families in crisis for up to 12 months to allow time for the family to stabilize their situation and to find child care with long-term funding.						

The length of child care services is flexible from weeks to the maximum of 12 months and is determined based on the type of family crisis. The majority of families served by the Bridge Program are homeless or near-homeless. Examples of other types of crises include the death, hospitalization, incarceration, or enrollment in substance abuse treatment of a parent. Families will be referred to Bridge Program services from community non-profit and public agencies that serve and case manage families in crisis. The referring agencies will be required to continue case management services. Many of the families are not eligible for other subsidized child care funding.
