### Subject

Authorize award and execution of a 36-month requirements service contract with BIG BOYS COLLISION CENTER, INC., to provide vehicle painting and refurbishment services for vehicles and equipment in a total amount not to exceed \$248,338, with three 12-month extension options in an amount not to exceed \$91,192 for the first extension option, \$95,752 for the second extension option, and \$100,539 for the third extension option, for a total contract amount not to exceed \$535,821.

# Amount and Source of Funding

Funding in the amount of \$72,210 is available in the Fiscal Year 2013-2014 Operating Budget of the Fleet Services Department. Funding for the remaining twenty five months of the original contract period and extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

This requirements service contract will provide a source for vehicle painting and refinishing services for minor body damage to various types of vehicles and equipment in the City's fleet. It will allow the City to extend the service life of the vehicle or equipment by repairing minor damage and repainting the unit. Before repairing and painting, the vehicle or equipment will be inspected mechanically to ensure that it is economical to do so and in the City's best interest. The services will be used by the Vehicle Support Services Division and the Fleet Service Centers.

This contract is intended to perform all minor body repairs and auto painting services for City vehicles needing to improve their overall appearance. There are no City facilities for these services at this time. This contract is necessary to support the Fleet Vehicle Support Services section with a reliable and continuous source of vehicle refurbishing and painting for City owned vehicles.
