This action will consider approval of an ordinance, after public comment, to adopt the proposed ninth modification to the Urban Renewal Plan (URP) for the East 11th and 12th Streets Urban Renewal Area as required by Chapter 374.014 (e) of the Texas Local Government Code. The property owner is working with Franklin's BBQ to redevelop the vacant lot with a two-story 4,000 square foot new commercial building to include, a "to–go" window, a food preparation area, and office and storage areas.						

The proposed URP amendment would allow the addition of commercial use as a permitted use to Tear Sheet 11-1/Juniper Mixed Use in support of the Franklin's BBQ Kitchen located at 901 Juniper Street. A separate zoning case is being brought forward to modify the Neighborhood Conservation Combining District (NCCD) Plan.
