

Commission for Women MINUTES

REGULAR MEETING July 10, 2013

The Commission for Women convened in a regular meeting on July 10, 2013 at City Hall, 301 W. 2nd Street, Room #1101 in Austin, Texas.

Chair Flannery Bope called the Board Meeting to order at 1:43 p.m.

APPROVAL OF MINUTES

• Chair Flannery Bope asked commission members to review minutes from the meeting on June 5, 2013. Commissioner Aguilar moved to approve the June 5 minutes. Motion was seconded by Commissioner Naranjo. Motion passed with no objection.

CITIZEN COMMUNICATION

• Texas Women in Business (TWIB) representatives spoke about their organization. They started a women's conference three years ago that was sponsored by the Governor's Commission for Women. It was called "Beyond 50" and helped older women who had been out of the work force for a long period of time; this event eventually extended to women in their 30s and 40s. TWIB representatives are asking City Council for funding and asking Austin Commission for Women for support of this project. Commissioners asked for more information and specifically what kind of support they are seeking.

OLD BUSINESS

Women's Hall of Fame event. Commissioners each brought their top three choices to the
meeting and gave them to Chair Bope. Tallies were taken. Harriet Murphy and Maria (LuLu)
Flores were tied for first with three votes each. Janis Pinnelli and Carole Strayhorn were tied
for second with two votes each. Commissioner Naranjo motioned for a slate vote to induct
these four women to the 2013 Hall of Fame. Commissioner Cuba seconded the motion, which
passed with no objection.

NEW BUSINESS

- Leadership Emerge Austin. Chair Bope attended an event hosted by Leadership Emerge Austin, and their members asked if the ACW would support them by adding the Austin Commission for Women name to the event. Commissioner Aguilar motioned to support Leadership Emerge. Commissioner Naranjo seconded. Motion passed with no objection.
- Women's Fund of Central Texas is looking to partner with Austin Commission for Women as
 they seek funding from various sources. They are compiling data and reports to find out what
 organizations would be most beneficial in helping women in the Central Texas area. They
 would like to speak to commission.
