# WORK SESSION MEETING TUESDAY, OCTOBER 1, 2013

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, October 1, 2013, City Hall at 301 W. Second Street, Austin, Texas.

Mayor Pro Tem Cole called the meeting to order at 9:05 a.m. Mayor Leffingwell and Council Member Martinez were absent.

# **COUNCIL ITEMS OF INTEREST**

Mayor Pro Tem Cole introduced the agenda for the October 3, 2013 Council meeting and allowed Council to give input or ask questions on any item posted on the agenda. Staff was available to provide verbal responses to Council questions. Discussion was held on the following items taken from Thursday's agenda.

57. Approve a resolution directing the City Manager to initiate amendments to City Code Chapter 25-2 (Zoning) to make the Rainey Street Sub-district eligible to participate in the Downtown Density Bonus Program and to address other density regulations affecting the Rainey Street Sub-district. (Notes: SPONSOR: Mayor Pro Tem Sheryl Cole CO 1: Council Member Chris Riley CO 2: Council Member William Spelman)

Mayor Pro Tem announced that a request to postpone this item will be made during the October 3, 2013 meeting. Direction was given to staff to provide Council with additional information on the history of the development of the Rainey Street Sub-district, a description of what it would take to earn extra square footage under the Rainey Street benefit program and possible policy options for the Rainey Street Sub-district.
