PROPOSAL

Demolish a ca. 1938 house.

ARCHITECTURE

One-story, rectangular-plan, side-gabled frame Colonial Revival-styled house with a central, recessed entry and an ornamental front gablet over it; single 6:6 fenestration; assymetrical composition; painted brick exterior chimney at the right (north) of the house; one-story, rectangular-plan, side-gabled frame addition to the left of the central block with an 8:8 front window.

RESEARCH


The house was built in 1938 for Lewis and Ruth Brownlow, who lived here the rest of their lives. Lewis Brownlow was a native of Austin, who worked for the Calcasieu Lumber Company his entire career, first as a stenographer, later as a store manager. His widowed mother, Zelda, had been an attendant at the Insane Asylum. In his later years, Lewis Brownlow contributed to the collections of the Austin History Center.

STAFF COMMENTS

The house is beyond the bounds of any City survey.

STAFF RECOMMENDATION

Recommend retention of the house, if possible; or recommend relocation over demolition, but release the permit upon completion of a City Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

BIOGRAPHICAL NOTES:

Lewis V. and Ruth Brownlow (ca. 1938 - ca. 2011)

Lewis and Ruth Brownlow appear as the owners of this house in the 1940 U.S. Census. The house was worth \$4,000. Lewis Brownlow was then 31, had been born in Texas, and was a stenographer. Ruth Brownlow was then 24, had been born in Texas, and was a coding checker for the Texas Insurance Checking Office. They had no children living with them.

The 1930 U.S. Census shows Lewis Brownlow as a 20-year old lodger in the home of Ben and Myrtle Dickerson in Athens, Texas. Lewis was single, and worked as an oil field surveyor.

The 1920 U.S. Census shows Lewis Brownlow as the 10-year old son of Zelda Brownlow, a widow, who rented a house at 4009 Guadalupe Street in Austin. Zelda Brownlow was a 36-year old Texas-born widow, who worked, along with her two sisters, as an attendant at the Insane Asylum.

Lewis V. Brownlow

Lewis V. Brownlow, age 86, a native of Austin, died Sunday, October 29, 1995.

Born February 1, 1909, he was a charter-member of Westminster Presbyterian Church where he served as Elder, deacon and Sunday school teacher. He worked for Calcasieu Lumber Company for 40 years and after retiring from Calcasieu, worked for First City Bank in the real estate department for 14 years. He served as a member of the Selective Service System (Travis Coun-Ty Draft Board) under four presidents, volunteered in Austin elementary schools and at the Old Bakery, and was a source of information about early Austin for various writers and the Austin History Center.

Survivors include his wife of 60 years, Ruth; son, Lewis Jr and wife, Rebecca of Austin; daughter, Becky Steinback and husband, John of Ohio; son, Dan of Austin; four grandsons, Edward, Thomas, Lewis and James Brownlow; brother-in-law, Martin_Singleton and wife, Charlotte of Bryan; and three nieces and nephews.

A memorial service will be held at 2:00 p.m. Tuesday in the Westminster Presbyterian Church with Reverend Laura Mendenhall officiating. A private graveside service will-be held.

Ruth Singleton Brownlow

Ruth Singleton Brownlow, 95, passed away on Wednesday, July 6, 2011. She was born in Kountze, Texas (Hardin County) on August 13, 1915 to Judge Daniel Floyd and Mary Singleton. She came to Austin in the early 1930s where she met and married Lewis Brownlow in 1935. They were married for 60 wonderful years until Lewis' death in 1995. She and Lewis were charter members of Presbyterian Westminster Church, and Ruth was active in all aspects of the church as long as she was able.

Ruth's greatest passions after family and church were golf, reading and baseball. She was a member of several Women's Golf Associations and golfed at least twice a week until her early 80's. She read constantly and always had a pile of library books beside her bed. She watched her team, the Chicago Cubs, anytime they were on television.

Ruth is survived by her three children, Lewis Jr. and his wife Rebecca, Becky Steinback and husband John, and youngest son Daniel who has been Ruth's major helper and caregiver for many years. She is also survived by five grandsons, Edward, Thomas, Lewis and James Brownlow and Ian Steinback, as well as three nieces, Martia Glass, Phyllis Adams, Mary Jo Enyeart and one nephew, Jim Singleton, and their families. She is preceded in death by her husband, her parents and her brother, Reverend James Martin Singleton.
