Structural reinforcement of buttresses.**

Speaker: John Volz, Volz & Associates, Inc.

Committee Recommendations: If interior intervention not possible prefer Option 2, with exterior steel frame providing increases thrust resistance but with a different geometry that references the shape of the existing buttresses.

2. C14H-1990-0013 - Republic Square

Master plan.

Speakers: Rey Hernandez, PARD Landscape Architect; Kim McKnight, PARD Project Coordinator; Rebecca Leonard, Design Workshop; Donna Carter, Carter Design.

Committee Recommendations: Simplicity of the design should be maintained to better reflect the history of the square as an open space. Committee members differed in opinion regarding possibility of a water feature.
