1. C14H-1990-0006 - Mount Bonnell

3800 Mount Bonnell Road

Monument and landscape improvements

Speakers: Ray Hernandez and Kim McKnight, Parks and Recreation Department. Fred Bothwell and Stan Bacon, West Point Society of Central Texas.

Committee Recommendations: The applicants must provide a clear understanding of the history of previous structures. Proposed changes to monument are a violation of the standards for historic sites.

**2. LHD-2012-0014 – Hyde Park Local Historic District
4404 Avenue F**

New construction on vacant lot.

Speaker: Kari Blachly

Committee Recommendations: Design has sufficient historical references, however windows should be placed closer together on facade.

**3. LHD-2012-0018 – Hyde Park Local Historic District
3813 Avenue F**

Extend existing front porch and revisions to previously approved rear additions.

Speaker: Mark Evans, architect.

Committee Recommendations: Fabricate a new porch post to replicate the existing posts, or cut the existing corner post to create two posts, and preserve existing handrail. Leave a seam between the existing and repurposed brick. Provide a detail for replacing single pane glazing with double panes in casement steel frame windows.

4. NRD-2012-0089 – 901 Congress Avenue

Demolish the building and construct a new multi-story building.

Speakers: Jeff Musgrove, American Realty. John Volz. Eric Herron, Jeff Neals, Six River Architects. Bob Brown, Big Red Dog. Greg Sindelar, Texas Public Policy Foundation.

Committee Recommendations: Proposed plan would set unfavorable precedent of demolishing historical buildings with compromised structures.
