#### 1154 Lydia Street

Proposal for site development and additions to the building.

**Speakers:** John Patterson, architect, and Greg Smith, Austin Revitalization Authority **Committee Recommendation:** Reconsider the form and location of the proposed addition so that the addition does not visually overwhelm the historic house and incorporate a more transparent connector between the historic house and the side addition.

**Committee Recommendation:** Save a sufficient number of tile and finial units to give an accurate representation of the original scale and profile for future reference.
