Additional Backup Information

The construction documents for the New Central Library are complete. The new library is located at 710 W. César Chávez Street and will house the collections and programs presently located in the John Henry Faulk Central Library. This "Library of the Future" will include all program elements outlined in the Architectural Building Program previously approved by City Council. Hensel Phelps Construction Company is currently constructing the utility infrastructure on 2nd Street and will soon begin the library's foundation.

In order to continue with the next phase of this project, an amendment is required. This amendment would include Phase C services which provide construction administration to include the following: reviewing contractor's submittals; providing necessary clarification and interpretation of contract documents; assisting in evaluating issues that arise during the course of construction; facilitating progress meetings; and providing a record set of drawings which depict changes accrued during construction. In addition, this amendment would include Phase D services which provide post construction warranty phase services.

This project is located in the 78701 zip code and is managed by the Public Works Department.

This amendment was approved by the City's Change Control Committee.
