Authorize award and execution of a 36-month requirements supply contract with LEIF JOHNSON FORD DBA LEIF JOHNSON FORD II LTD LTD to provide Parts and Repair Services for Ford Light Duty Vehicles in a total amount not to exceed \$630,348, with three 12-month extension options in a total amount not to exceed \$231,367 for the first extension option, \$242,886 for the second extension option, and \$254,980 for the third extension option, for a total contract amount not to exceed \$1,359,581.

Amount and Source of Funding

Funding in the amount of \$183,333 is available in the Fiscal Year 2013-2014 Operating Budget of the Fleet Services Department. Funding for the remaining twenty five months of the original contract period and extension options is contingent upon available funding in future budgets.

This repair service contract is intended to be used to supplement the Ford light-duty repairs performed by the City's mechanics in the Fleet Service Centers. Approximately 20% of the City's fleet is made up of Ford light-duty vehicles. This contract is necessary to support the automotive and equipment fleet service centers with a reliable and continuous repair source.
