## Subject

Authorize award and execution of a 36-month requirements supply agreement with MCCAIN, INC. for the purchase of automated traffic signal controllers for the Transportation Department in an amount not to exceed \$764,250, with three 12-month extension options in an amount not to exceed \$254,750 for each extension option, a total contract amount not to exceed \$1,528,500.

## Amount and Source of Funding

Funding in the amount of \$212,292 is available in the Fiscal Year 2013-2014 Operating Budget of the Transportation Department. Funding for the remaining 26 months of the original contract period and extension options is contingent upon available funding in future budgets.

## Additional Backup Information

This contract will provide automated traffic signal controllers which are used at intersections throughout the city to control the traffic signals. The controllers are what makes the light turn green, yellow, and red and establishes communication with the Traffic Management Center providing intersection status and programming capabilities. These controllers are also used to program all of the timing parameters to make the signal turn colors. The city's central software keeps track of the status of all the controllers.
