9. Staff update on Community Technology Initiative and the Grant for Technology Opportunities Program (GTOPs). (John Speirs) (wp2)

John Speirs, Program Coordinator with the City of Austin Office of Telecommunications & Regulatory Affairs reported that the GTOPs applications are ready and online at GTOPS.org which is due to the City on December 10, 2013. Marketing is being done with a press release, post cards, and Channel 6.

A conference call will be held November 1st from 2:00 to 4:00 pm for technical assistance with the online grant application process.

The City is currently looking for GTOPs grant reviewer from the community. You can also find that application on GTOPS.org with a deadline of November 29.

 Update on Google Fiber Community Connections Program (Rondella Hawkins/John Speirs) (wp3)

John Speirs, stated that staff is reviewing and assessing 308 site applications for a Google 1 gigabit connection.

The Commission is scheduled for a special called meeting November 6 for feedback related to the structure and format of the matrix in which we utilize, rate, and score the applications based on the City Council approved criteria. The Commission will make a recommendation on methodology and ranking that will then be forwarded to the Emerging Technology and Telecommunications Council Committee at their November 13th meeting.

November 21st this item will go before City Council for approval of 100 sites to receive the connection and list of approved sites will then be announced in December.

The Commission created a Community Connection Working Group to help prepare for the November 6^{th} special called meeting. This group includes Commissioners White, Rosenthal and Williams. Commissioner Ramsey will be an alternate.

11. Update from Open Government Working Group. Discussion and possible action on: a) recommendations for mission and objectives of the innovation office, b) future direction for commission and working group activity in support of open government initiative. (Chip Rosenthal) (wp4)

Commissioner Rosenthal gave a brief update from the Open Government Working Group then presented draft recommendations relating to the creation of an Office of Civic Innovation.
