## HISTORIC LANDMARK COMMISSION DECEMBER 16, 2013 DEMOLITION AND RELOCATION PERMITS HDP-2013-0889 2019 E. 3<sup>rd</sup> Street

## PROPOSAL

Demolish a house of unknown age moved onto the current site ca. 1949.

### ARCHITECTURE

One-story, wing-and-gable plan, frame house with a partial-width, inset porch on turned wood posts with a gingerbread-style frieze and a non-historic railing; single 2:2 fenestration; corrugated metal roof.

#### RESEARCH

The applicant states that the house was moved from its original site on Paul Street (south of W. 5<sup>th</sup> Street) in 1949, and comparison of the footprint of the house with some houses on in the 400 block of Paul Street on the 1935 Sanborn map support that conclusion, but it is not clear which house this one is. The houses on Paul Street that were shown on the 1935 Sanborn map are not shown on the 1961 map, further supporting the conclusion that the house was moved to this site from Paul Street. However, staff has not been able to locate a building permit documenting the move of the house from Paul Street to the current site.

The age of the house is undetermined, but it appears to have been built in the 1900s or 1910s, given its style and fenestration configuration. This area of the city was not shown on any Sanborn map prior to that of 1935 to help pin down a more accurate construction date.

Since the move of the house to the current site in 1949, the house has served as a rental property with a high turnover in tenants, who were all of Hispanic descent.


#### STAFF COMMENTS

The house does not appear on any City survey.

The house has suffered some fire damage to the interior and roof trusses; there are two other houses on the site that the applicant is restoring, but this one has less structural integrity than the others and the applicant has determined that preservation and restoration are not feasible.

#### STAFF RECOMMENDATION

Encourage relocation over demolition, but release the permit upon completion of a City of Austin documentation package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.







The east side of Paul Street had no houses matching the footprint of the existing house (1935 Sanborn map)



The September,1961 Sanborn map shows that the houses shown above had all been removed from the site, and that the site was then occupied by a paper warehouse.

Here is everything I know. You guys can probably find more.

Information on the houses won't be under East Austin or 3rd street. The houses on 2017 and the house in question on 2019 are identical. They were built on paul street in 1915 (where the Land Rover dealership is now) right next to each other and were moved here in December of 1949. The moving permits are on note cards at the Austin History Center. We originally had problems finding information because we were looking at 3rd. The bought and moved them was Capital Investment Inc.

The big house on 2019 was moved in May of 1950 and was moved from the mentioned address on Bowie. It was built originally in 1910 by a man named Roy or Ray Nunez. Roy was the father and Ray the son or vice versa. I cannot remember. The father was a stenographer I think.
