#### A. CALL TO ORDER

Board Chair Kite called the meeting to order at 5:38PM.

#### **B. APPROVAL OF MINUTES**

- 1. Approve the minutes of the Urban Forestry Board meeting of October 16, 2013.

  Motion made by Board Vice-Chair Maceo, Seconded by Board Member Fleming to approve the meeting minutes of the Urban Forestry Board October 16, 2013. Board Members in favor: Fleming, Kite, Maceo and Newsom. Board members Brewer and Classen abstained. Motion passed with four yes, two abstained. One vacant position.
- 2. Approve the minutes of the Special Called Urban Forestry Board meeting of October 30, 2013. Motion made by Board Member Brewer, Seconded by Board Member Newsom to approve the meeting minutes of the Special Called October 30, 2013 meeting. All members present in favor. One vacant position.

- Barton Springs Pool tree court work to be starting this week.

#### G. DISCUSSION AND ACTION ITEMS

1. Approve meeting location for calendar year 2014. Presenter: Chris Kite, Board Chair. Motion made by Board Member Classen, Seconded by Board Vice-Chair Maceo to have the calendar year 2014 Urban Forestry Board meetings at Northwest Recreation Center. Board members Kite, Fleming, Brewer, Classen and Maceo in favor. Board member Newsom opposed. One vacant position. Vote passes five votes for, one opposed, one vacant.

- 2. Consider approval of items related to Urban Forestry Board Comprehensive Urban Forest Plan.
  - Motion made by Board member Brewer, Seconded by Board member Newsom to accept all changes brought by Urban Forestry Board working group, to date, with the exception of the Annual Performance Report Card. All Board members present in favor. One vacant position.
  - Motion made by Board member Fleming, seconded by Board member Brewer to implement changes agreed to by consensus on changes previously made by Board members Maceo and Classen. All members present in favor. One vacant position.
  - Motion made by Board member Brewer, Seconded by Board member Fleming to accept the letter from Urban Forestry Board, written by Urban Forestry Board Chair with word change suggested by Board member Classen. All members present in favor. One vacant position.
  - Motion made by Board member Classen, Seconded by Board Vice-Chair Maceo that the Report Card document, as presented by Board member Classen at the working group on Friday, November 15, be part of the Austin Urban Forest Plan. Board members Classen and Maceo in favor, Board members Fleming, Brewer, Kite and Newsom against. Motion fails. One vacant position.
  - Motion made by Board member Fleming, Seconded by Board member Newsom to include the plan with the framework for the first two columns and last column, leaving the other columns open, and have the Urban Forestry Board review performance indicators annually and update as appropriate. Board members Fleming, Newsom, Brewer and Kite in favor. Board members Classen and Maceo against. One vacant position.
  - Motion made by Board member Brewer, Seconded by Board member Fleming to accept the Urban Forest Plan in the most recent draft form with changes accepted tonight including technical edits to be made by staff (i.e., grammar and factual accuracy), and a more appropriate cover photo focusing on trees in the foreground and an urban setting in the background. Board members Kite, Brewer, Fleming and Newsom in favor. Board member Classen opposed. Board member Maceo abstained. Motion approved. One vacant position.
  - Board Chair Kite mentioned that the October 16 Environmental Board (ENVB) recommendations
    included a request to bring the Plan back before the ENVB after changes had been made. This could
    result in UFB participation at a December ENVB meeting. Urban Forestry staff agreed to develop a
    detailed written summary of these changes that could be sent on to the ENVB. Urban Forestry staff
    will send a draft of the Plan changes to UFB Board Chair Kite, who will then make possible edits
    before sending the summary on to Chair Maxwell of the ENVB.
