   Motion made by Board Member Fleming, Seconded by Board Member Newsom to forward changes as discussed in memo to be sent to the Chair of the Environmental Board. Board members Kite, Maceo, Brewer, Classen, Fleming and Newsom in favor. Board member Brown non-voting this meeting. Motion passed.
