MBE / WBE:

This contract was awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) with 5.88% MBE and 1.81% WBE subcontractor participation to date.

Additional Backup Information

Chapter 2267 of the Texas Government Code authorizes governmental entities to award Job Order Contracts to one or more Contractors for maintenance, repairs, alteration, renovation, remediation, or minor construction. The 2013 Job Order Contract (JOC) is the City's second job order contract and has been successful in meeting various departments' minor construction and facility improvement needs.

The JOC was executed in January 2013 with a budget of \$6,000,000 for an initial two-year term. Due to the favorable City-wide use of the JOC, we anticipate the \$6,000,000 budget authority to be consumed well before the end of the contract term. In order to meet the demand for this contract program, additional funding authority is required in an

amount not to exceed \$6,000,000, which will be distributed among the Job Order Contractors based on work authorization and availability.

MBE/WBE PARTICIPATION TO DATE:

In the first eleven months of the two-years of the 2013 JOC program, there have been 12 Job Order assignments of which some required specialized work and did not allow for greater utilization of MBE /WBEs. For example, at the Austin Animal Center, a specific disease control flooring and approved installer for the surgical area was required, and at Ulrich Water Treatment Plant it was necessary to replace LSP 6 Actuator and gear box with the compatible specified Rotork IQ 12-43 rpm actuator valve.
