Additional Backup Information	

The Job Order Assignment will be made under the 2013 Job Order Contract for City of Austin Facility Improvements. Office space renovation for four new Council Members is currently in design. The work consists of renovating approximately 6,375 square feet of existing office space on the 2nd floor, east wing of City Hall into four (4) new Council Member office suites, four (4) new conference rooms, a coffee bar, and a break lounge.

Completion of design is scheduled for mid-to late March 2014 and construction work must begin immediately thereafter to meet the final completion date of September 30, 2014. To meet this very compressed design and

construction schedule, the work will be assigned to one of the existing Job Order Contractors through the City's existing 2013 Job Order Contact program. Other construction delivery methods such as the traditional invitation for bids and competitive sealed proposals were explored, but were deemed not viable options due to their lengthy solicitation schedules.

Pursuant to State statute, the City is required to obtain approval from Council for any job order assignment that exceeds \$500,000. The preliminary design cost estimate from the design consultant for these renovations is \$1,100,000. This request is for Council authorization to negotiate and execute a Job Order Assignment to KBR, LLC, Austin, TX, under the 2013 Job Order Contract in an amount not-to-exceed \$1,100,000 plus \$55,000 contingency for a total amount not to exceed \$1,155,000.
