**ANALYSIS / ADDITIONAL INFORMATION:** This budget amendment will allow the Public Works Department to move forward with the River Plantation Bridge Approach project. During the Halloween flood event on October 30, 2013, the embankment supported by the retained earth wall (the "Embankment") adjacent to the River Plantation Drive Bridge over Onion Creek was severely compromised. The Public Works Department has done further investigation and engineering analysis and concluded that the damaged and missing mechanically stabilized earth wall panels and loss of engineered backfill has rendered this bridge approach unsafe for vehicular use. The Embankment structure is a danger to the travelling public and cannot be opened even for emergency vehicular traffic. Left untreated, there is a high likelihood of additional deterioration, which would extend the damage further into the remaining Embankment.
