On June 13, 2013, the CDC approved programmatic recommendations to NHCD regarding boundaries of the Holly Good Neighbor Program.

On March 13, 2012, the CDC appointed a Working Group to study the issue and bring back recommendations. On November 13, 2012 the Working Groups final report was presented to the CDC. On December 11, 2012 the CDC approved drafting a memo to Council with their recommendations. On March 12, 2013 the CDC approved the Amended FY 2012 CSBG budget. *Responsive to state and federal CSBG requirements.*

On October 8, 2013, the CDC approved a motion to ask Council to delay the passage of the Urban Farm Ordinance and support the creation of an independent body including relevant stakeholders and a member of the CDC for further review.

The CDC will continue to fulfill its core mission "to advise the Council in the development and implementation of programs designed to serve the poor and the community at large with emphasis of federally funded programs."

The CDC's goals and objectives for 2014 also correspond to one of Imagine Austin's Guiding Principles to "develop as an affordable and healthy community. This also includes the sixth Imagine Austin Priority Program: "household affordability throughout Austin." Some areas where the CDC will continue to work are:

- **<u>Downtown Austin Plan.</u>** Continue to receive briefings, monitor the plan, and complete work as directed by Council.
- <u>Image Austin Comprehensive Plan</u>. Continue to receive briefings, monitor the plan, and complete work as directed by Council.
- <u>University Neighborhood Overlay (UNO)</u>. Continue to work with the Planning Commission to forward recommendations as directed by Council.
- <u>East Riverside Corridor Plan.</u> The CDC will continue to monitor and participate in the development on this corridor plan especially as it pertains to the development of affordable housing.
- <u>PUDs</u>

Continue to monitor and review revisions in the development of PUDs so that they include input for opportunities to include low-income housing.

• <u>TODs</u>

Continue to monitor the development of TODs around Austin for opportunities to build low-income housing.

• <u>VMU</u>

Continue to monitor the density bonus so that the correct amount of affordable housing is created.

- <u>HUD Community Challenge Grant for Colony Park.</u> The CDC will continue to receive briefings and monitor the progress of the Colony Park grant, as well as other projects in the Colony Park neighborhood with standing quarterly updates at the Housing Committee.
- <u>Holly Good Neighbor Program.</u> Continue to work on the charge to discuss the future funding of the Holly Good Neighbor Program, how funds might be reallocated; and how to educated residents about the program.
- <u>Preservation of low- and moderate-income housing</u>. Continue to work with stakeholders, non-profits, and other organizations to ensure the preservation of low- and moderate-income housing remains a City priority.
- <u>**Rental Registry**</u>. Continue to monitor the implementation of the pilot program. Continue to work with Code Compliance and others to develop a strategic policy for ensuring low- and moderate-income housing is maintained and remains safe for residents.
- <u>**Tenant Relocation Policy**</u>. Continue to work with the City, stakeholders, non-profits and others to develop a tenant relocation policy that ensures low-income residents that must relocate are given the needed resources and help to establish themselves in a new home.
