

ORDINANCE NO. _____

1 AN ORDINANCE ESTABLISHING INITIAL PERMANENT ZONING FOR THE
2 PROPERTY LOCATED AT 11901 ANDERSON MILL ROAD AND CHANGING
3 THE ZONING MAP FROM INTERIM-RURAL RESIDENCE (I-RR) DISTRICT
4 TO COMMUNITY COMMERCIAL-CONDITIONAL OVERLAY (GR-CO)
5 COMBINING DISTRICT AND COMMERCIAL-LIQUOR SALES (CS-1-CO)
6 COMBINING DISTRICT.

8 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

10 PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to
11 change the base district on the property (the "Property") described in Zoning Case No.
12 C14-2013-0146, on file at the Planning and Development Review Department, as follows:

15 Tract 1:

16 From interim-rural residence (I-RR) district to community commercial-conditional
17 overlay (GR-CO) combining district

19 Lot 4, Block A, Volente Subdivision, a subdivision in the City of Austin, Travis
20 County, Texas, in Document No. 200000061 of the Official Public Records of
21 Travis County, Texas,
22

23 Tract 2:

24 From interim-rural residence (I-RR) district to commercial-liquor sales (CS-1-CO)
25 combining district
26

27 10,123 square feet of land, more or less, out of Lot 4, Block A, Volente
28 Subdivision the tract of land being more particularly described by metes and
29 bounds in Exhibit "A" incorporated into this ordinance,
30

31 locally known as 11901 Anderson Mill Road in the City of Austin, Travis County, Texas,
32 and generally identified in the map attached as Exhibit "B".

34 PART 2. The Property within the boundary of the conditional overlay combining district
35 established by this ordinance is subject to the following condition:
36

1 A site plan or building permit for the Property may not be approved, released, or
2 issued, if the completed development or uses of the Property, considered cumulatively
3 with all existing or previously authorized development and uses, generate traffic that
4 exceeds 2,000 trips per day, unless a Transportation Impact Analysis (TIA) is
5 submitted and approved by the director of the Planning and Development Review
6 Department.

7
8 Except as specifically restricted under this ordinance, the Property may be developed and
9 used in accordance with the regulations established for the community commercial (GR)
10 base district and commercial-liquor sales (CS-1) base district and other applicable
11 requirements of the City Code.

COUNTY, TEXAS OFFICIAL RECORDS. SAID TRACT BEING MORE
PARTICULARLY DESCRIBED BY METES AND BOUND DESCRIPTION
AS FOLLOWS:**

Beginning at a ½" iron pin found at the Southeast corner of said Lot 4, Block A also being on the North line of Lot 1 Sophies Choice Subdivision, a subdivision recorded in Plat Book 100 Page 270 of the Travis County, Texas Plat Records for the POINT OF COMMENCING.

THENCE N 51° 26' 28" W with the common line of said Lot 4, Block A and Lot 1, 97.93 feet to a point.

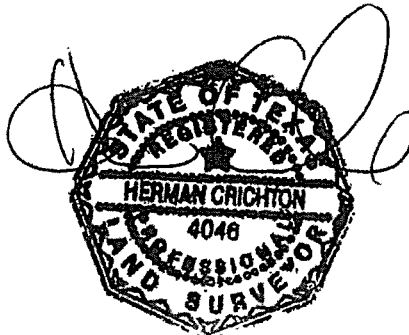
THENCE through the interior of said Lot 4 the following seven (7) courses:

- 1) N46°25'52"W, a distance of 138.44 feet to a point for the Southwest corner of this tract.
- 2) N43°34'08"E, a distance of 49.39 feet to a point for the Northwest corner of this tract.
- 3) N88°34'08"E, a distance of 29.14 feet to a point.
- 4) S46°25'52"E, a distance of 110.79 feet to a point for the Northeast corner of this tract.
- 5) S01°25'52"E, a distance of 29.14 feet to a point.
- 6) S43°34'08"W, a distance of 35.83 feet to a point for the Southeast corner of this tract.
- 7) S88°34'08"W, a distance of 19.18 feet to a point. to the POINT OF BEGINNING and containing 10,123 square feet, more or less.

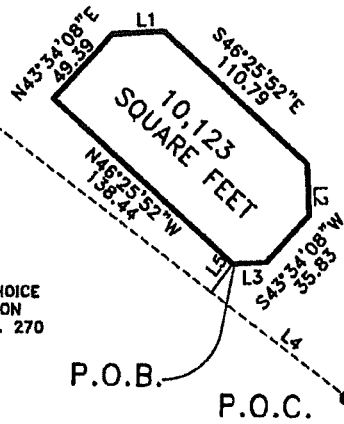

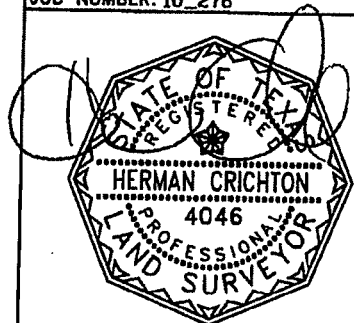
