Authorize award and execution of a 36-month requirements supply agreement with TRILLIUM DEVELOPMENT LTD CO., to provide traffic signal cables in an amount not to exceed \$705,006 with three 12-month extension options in an amount not to exceed \$235,002 per extension option, for a total contract amount not to exceed \$1,410,012.

Amount and Source of Funding

Funding in the amount of \$137,085 is available in the Fiscal Year 2013-2014 Operating Budget of the Transportation Department. Funding for the remaining 29 months of the original contract period and extension is contingent upon available funding in future budgets.


