The primary scope of work includes the construction of 0.8 miles of four lane divided arterial roadway with a raised center median, bike lanes and sidewalks on both the eastbound and westbound sides of the roadway. The new arterial roadway eliminates the bottleneck west of Brodie Lane and an offset intersection.

The project is intended to increase mobility, decrease congestion and fuel consumption, improve air quality and safety in the area. There are no other alternatives within the existing right of way to the proposed project that provide the same or better congestion relief with improved air quality. In addition, no other roadways in the area provide a connection between Corran Ferry and Brodie Lane.

Funding for Change Order No. #2 will cover the following unexpected contract items:

- Additional bedding for storm pipe due to redesign
- Additional base material to replace removed soil that was not lime treated
- Changing in size of junction boxes
- Additional manholes
- Change to air release valve (ARV) sizes and restocking of ARVs originally specified
- Larger encasement pipe for water line
- Relocating existing 16-inch waterline that conflicts with the storm drain pipe
- Rock sawing to install storm drain after a redesign to avoid utility conflicts
- Extra road entrance for a nearby apartment complex which will facilitate Fire Department access
- Remediation of karst features encountered during construction.

This change order is pending review by the City's Change Control Committee.

This project is located within zip code 78749 and is managed by the Public Works Department.
